NOW, THEREFORE, it is ORDERED that, until appropriate equipment, technology, and/or engraving plates have been obtained and put into use, County Clerk Sandy Yates shall use the existing and available file-marking mechanisms and/or equipment and strike the name of the former Clerk by hand and replace by hand or stamp the signature of the current Clerk and initial the same in connection with her duties as Clerk of the Nacogdoches County Commissioner's Court as well as the County Court. Nothing herein shall be construed to alter, change or modify the Order signed January 3, 2023, by County Court at Law Judge Jack Sinz and filed under Document Number 2023-6 in the Nacogdoches County Clerk's Office.

Any altering of the file-mark pursuant to this Order shall not be considered an alteration to any document or instrument, but only a means of complying with laws of this State. This Order shall remain in effect until this matter may be considered by the Nacogdoches County Commissioner's

Court or until the new means of applying a file-mark is obtained whichever occurs first. The County


