No registre a personas para votar con direcciones residenciales que no sean del condado de Nacogdoches. El solicitante DEBE proporcionar una dirección residencial física dentro del condado de Nacogdoches. Necesitamos saber dónde vive realmente el solicitante para poder asignar un recinto. Un apartado postal no es una dirección residencial.

El solicitante puede dar **CUALQUIER** dirección para su **dirección postal**, incluyendo un apartado postal o una dirección fuera de la ciudad. Esto es solo para la **dirección postal**. El solicitante **DEBE** proporcionar una **dirección residencial física** dentro del condado de Nacogdoches. Si la **dirección postal** es la misma que la **dirección residencial**, la **dirección postal** puede dejarse en blanco.

Inscripción de estudiantes de SFA

Un estudiante de SFA que vive en el campus debe proporcionar el nombre del dormitorio en el que vive en la sección de **Dirección Residencial** de la Solicitud de Registro de Votantes. La dirección de apartado postal o la dirección particular de un estudiante de SFA solo debe proporcionarse en la sección de Dirección postal de la Solicitud de Registro de Votante.
